

# Public Safety Subcommittee MEETING MINUTES

## Wednesday 5/14/2025

#### 1. Welcome

Note: As the majority of discussion in this meeting is referencing the telephonic handoff between hotline responder staff and the operators who respond on non-emergency lines, this meeting is optional for law enforcement officers.

  - Purpose: Discuss the handoff process for hotline reporters' referral to law enforcement PSAPs (public safety access points).
  - Outcome: Clearer understanding of the expectations around a referral to law enforcement from the hotline.
  - Process: Review example scenarios together and determine what elements should be included in a handoff.

### 2. Subcommittee Discussion

Referral Discussion

- Warm handoff
  - PSAPS: once the hotline responder has confirmed that the victim was successfully connected with the PSAP operator, you do not need to stay on the line. Only concern would be if hotline responder interrupts the conversation.
  - LE officers would want to know the contact information for the hotline responder staff, their email or phone number, in order to follow up with the person of contact/who initiated the call
  - Suggestion to hotline responder staff: empower the victim, ask them prior to connecting to LE: do you want me to stay on the call after I summarize the information you consented to?
  - Other warm transfers to PSAPs include mental health services, or PSAP-PSAP
  - Give victim heads up that the PSAP/LE may repeat the questions you have already answered and that will differ based on PSAP jurisdiction, some are more detailed than others.
  - Average connection call will be 3 minutes or less.

Keep in mind that interpreters from Language Link may be dropped off once connected to PSAP, they may be tied to the hotline responder. AGO needs to test their phone system, but PSAPs also use LanguageLink.
