STIPULATED MOTION FOR  
DISMISSAL

Plaintiffs Washington State Department of Social and Health Services (“DSHS”) and State of Washington, and Defendant Fidelity Information Services, LLC (“FIS”) (jointly, the “Parties”) by and through their respective attorneys, hereby stipulate and agree that DSHS and FIS have a contract dated October 4, 2022, for the provision of Electronic Benefit Transfer (“EBT”) services, and the contract includes mutual obligations regarding the disclosure of Confidential Information (as defined in the contract).

Plaintiffs filed this case seeking an injunction to prevent an alleged breach of the confidentiality obligations in the contract. The Parties stipulate and agree that, in compliance

1 with the contract, neither Party has disclosed or agreed to disclose any Confidential Information,  
2 and the Parties reaffirm their intent to comply with their mutual obligations under the contract,  
3 including those regarding notice of legal requests for Confidential Information.

4 The Parties stipulate and agree that the above-entitled action should be dismissed without  
5 prejudice. Each Party will bear its own attorneys' fees and costs.
