

OMVLA Data: Q2 2025

April 1st, 2025-June 30th, 2025



Data Highlights

- Slight decrease in requests from Q1 2025 (150 requests)
- Increase in requests from rural residents (10% of requests in Q1, 18% of requests in Q2)

Pro Bono Referrals

- We requested pro bono advice from our volunteers for **69% of community members** in Q2.
- Attorneys **accepted 68% of our requests** (including cases where community members did not provide conflicts information).
 - About twice our 2024 acceptance rate.

Pro Bono Recruitment

- Finished emailing **family law** attorneys and **new bar admittees** (754 emails)
- Successfully recruited 17 attorneys from this effort, primarily family law.
- Compiling emails of consumer law and bankruptcy attorneys

- Discussed Q1 requests including number of requests, most prevalent legal issues, top rural counties, and income distribution of requestors

- Ian shared about his AGO Legislative Fellowship experience
- OMVLA's 2025 priority is recruiting new pro bono attorneys and retention of current volunteers
 - Mariah recruited 29 new volunteer lawyers, primarily in family law, and discussed the methods she used to recruit new volunteers
 - Beginning in June, OMVLA will conduct phone interviews with current volunteer attorneys for their feedback
