Groom, which are used in furtherance of violating the Court's 22 Order Granting the State's Motion for Preliminary Injunction, Dkt. 37, including: (1) 23 efilebusiness.com; filingsonline.com; (3) filingscompliance.com; (4) 24 (2) 25 annualmminutes.com; (5) e-filebusiness.com; (6) washingtonfiling.com; **(7)** annualreport-filing.com; and (8) meetingmin.com. 26

1	(2) GoDaddy shall ensure that suspension of all relevant domains prohibit Defendants from
2	using such domains to communicate with or obtain payments from Washington
3	consumers.
4	(3) Prohibit Defendants from registering, obtaining, or otherwise using any other domain,
5	which may be used for the purpose of sending communications to Washington consumers
6	or conducting business in Washington, in violation of the Court's Preliminary Injunction
7	Order, Dkt. 37.
8	The Court's Order shall remain in effect for the duration of this litigation.
